Dear Chief Burch,

The Southwest Virginia Firefighters Association held its quarterly meeting at the Newport Volunteer Fire Department in Newport, Va. on Sunday, 25 September 2011. At this meeting the members of the association discussed the possibility of re-certifications through the Virginia Department of Fire Programs. While this association feels that re-certification would not be beneficial to the fire service, the association would like to see a continuing education program in place of re-certifications.

Due to shrinking department budgets and volunteers work and family time being a premium, a continuing education program could offer a solution to keep the firefighters in the Commonwealth of Virginia trained to the highest possible levels. Some of the ideas that were discussed at this meeting to achieve this level of training were;

- Credit for in-house department training
- Online training
- ISO training
- ICS training
- National Fire Academy training
- Other local training opportunities

With 63.5% of the fire departments in the Commonwealth of Virginia being volunteer, it is becoming increasingly harder for members to attend trainings and re-certifications. Due to the demands of time and family, this makes long re-certification classes harder to accomplish.

It is the opinion of the Southwest Virginia Firefighters Association that the creation of a continuing education program would be the most beneficial for firefighters, both career and volunteer, as well as providing the citizens of the Commonwealth of Virginia with the highest level of fire protection.
