### **Legislative Committee:**

Mr. Mike Moles offered the following report:

- Attended the Mid-Winter Conference:
  - Reported that there have been changes to the Aid to Localities Money
  - Fire departments cannot buy fitness equipment with this funding
- House Bill 1202:
  - HB 1202 Fire policy; shall provide coverage for cost charged by volunteer fire department, etc.
    - Introduced by: Joseph P. Johnson, Jr.
  - Fire insurance; coverage for costs of services by volunteer fire departments. Requires fire insurance policies to provide coverage, with limits not less than \$250, for the cost charged by a volunteer fire department that is not fully funded by property taxes in certain instances when the fire department is called in to save or protect property insured under the policy. Higher coverage limits may be offered for an additional premium. The amount billed shall not exceed the limit of coverage. This bill is identical to SB 140.

  - This bill is not to pay for the fire department operations
  - The billing will be an option for the fire department or locality
